EOI FOR EMPANELMENT OF LEGAL ADVISOR ON PART TIME BASIS

Small Farmers' Agribusiness Consortium (SFAC) a society under Ministry of Agriculture, Govt. of India seeks to empanel Legal Advisor(s) (two to three) on part time basis to provide legal advisory services from time to time, task wise.

1. An illustrative nature of tasks is given below

- (i) Preparing legal documents for executing agreements with promoters availing Venture Capital Assistance.
- (ii) Notices under Section 138 of N.I. Act and filling of cases.
- (iii) Filling of claim petition and attending court cases of Venture Capital Cases, & any other cases, if required, in various courts.
- (iv) Compromise settlement etc.
- (v) Arbitration cases under Arbitration Council of India/Sole Arbitration and their execution.
 (i) Filling, (ii) appearance till award and (iii) execution of decree in respective courts.
- (vi) Matters regarding lease agreement.
- (vii) Issues related to Property tax
- (viii) Ensuring recovery of VCA amount from the beneficiaries as per terms/agreement by way of legal demand notices etc.
- (ix) Preparation of agreement regarding loan scheme etc.
- (x) Review of present format of various agreements to make it broad based and legally enforceable.
- (xi) Legal opinion in various matters.
- (xii) Preparing legal documents as and when required.
- (xiii) Any other cases of legal nature as and when required.

2. Eligibility Criteria

- (i) Advocates/Law firms should have experience of above stated work for minimum of 10 years.
- (ii) They should have been on the panel of at least two institutes or organization/public sector banks/public financial institutions.
- (iii) Advocates/Law firm shall be empanelled for a period of two years and his/their services shall be availed from case to case basis on a fee agreed by the organization.

Any other expenses incurred by the advocate/law firm shall be reimbursed as per actual.

3. **Reservation of Rights**

The Consortium reserves the right to short-list the advocates based on firms' credentials/field of specialization/experience etc. Number of empanelled consultants may increase or decrease. Empanelled consultants may be assigned the task anywhere in India.

4. Submission Expression of Interest.

Bidders should submit their qualification in two separate sealed envelopes, marked as "Quotation for empanelment of Legal Advisor". Sealed cover marked 'A' should contain the firms credentials/their field of specialization/ experience/name of the clients.
