## <u>Minutes of the Joint Review Meeting on Progress of FPOs formed in Uttar</u> <u>Pradesh held at Kisan Mandi Bhawan, Gomati Nagar Lucknow, Uttar Pradesh</u> <u>on 22nd June 2018.</u>

A meeting was convened on 22<sup>nd</sup> June 2018 to jointly review, the progress of FPOs formed in Uttar Pradesh, with the State Government and concerned Resource Institution (RIs). The meeting was Chaired by Shri Sumanta Chaudhuri, IAS, MD SFAC.

The points which were discussed as per agenda of the review meeting:

- MD, SFAC explained the importance of FPOs and Government's (PMO) increasing emphasis on strengthening FPOs. He expressed his unhappiness on the mobilisation & collection of equity of the FPOs & directed all the Resource Institution to expedite the mobilisation & collection of farmer share and enhance the share capital to Rs. 10.00 lakh for equity Grant.
- MD also emphasized the need to strengthen the FPOs by availing the benefits of SFAC's schemes such as Equity Grant, Credit Guarantee and VCA schemes.
- MD instructed all the RIs to work for sustainability of FPOs by dovetailing Central/ State Government Schemes and by establishing necessary market linkages.
- MD drew the plight of FPOs in getting requisite licences for trading, insecticide, fertilizer and seed. MD requested the State Government to expedite the process for issuing the requisite licenses to FPOs.
- Additional Director informed the RIs that necessary instruction will be issued to all the Mandi's for expediting the Mandi licenses. Besides, he asked the RIs to contact the Division level officers for the same.

As instructed by MD, the RIs have given following timeline for accomplishing the following activities:
