EMPANALMENT OF TAXI HIRING AGENCIES

TERMS & CONDITIONS

- 1. Located in South-East Delhi preferably near area like Jasola, Sarita Vihar, Apollo Hospital etc.
- 2. Rates quoted should be for monthly requirement of kilometer mileage and hours would be 24 days; 2400 km; and 320 hours per month. Charges for extra days and extra km and hour shall be also quoted separately.
- 3. The contract will be valid for a period of one year from the date of agreement which can be extended further on same terms & conditions. The office reserves the right to curtail or to extend the validity of contract. In case of any steep hike in petrol/diesel price can be revised only after six months on mutual consent
- 4. Details of registration, PAN No. valid insurance and full particulars of owner must also be provided
- 5. Bidder should have minimum ten DLY registered Taxies with Regional Transport Authority.
- 6. The agency shall abide by all statutory requirements for running the hiring contract SFAC shall have no responsibility and no way be liable towards taxes, fees, cost of diesel/petrol/Mobile and salary to drivers, maintenance etc. or any other charges payable in respect of running the car hiring contract except the contract price. Only toll taxes and parking charges shall be paid by SFAC on submission of proper receipt.
- 7. The selected agency will have to deposit Rs. 20,000/-(Rupees Twenty thousand only) in the form of Demand Draft payable at New Delhi in favour of SFAC; in case of non-submission of security deposit within the stipulated period the offer will be treated as cancelled.
- 8. The selected agency will provide latest model in excellent running conditions with proper upholstery. In case the vehicle provided by the agency is found in any unlawful activity, SFAC will not be responsible for the same.
- 9. Drivers should possess a valid driving commercial license with batch No. for LMV; well mannered, experienced, and well uniformed and should carry a mobile phone also.
- 10. In case of breakdown of any vehicle the contractor shall replace the breakdown vehicle within one hour failing which SFAC has the right to hire vehicle from any other sources at the expense of the contractor.
- 11. Office may make inspection/field survey regarding number of vehicle, driver etc. through a committee, before selection process.
- 12. The agency shall ensure that all the necessary documents (Registration certificate, insurance papers PUC.etc.) are available with drivers.
- 13. The agency will provide the bills in triplicate made date-wise by the contractor and should be submitted to the Administration section of the department on monthly basis.
- 14. All documents of the vehicles and conditions of vehicles will be checked by concerned dealing official on random basis once in a month

PENALTIES: For non-providing of vehicle in time Rs.200/- per hour of delay; for not providing substitute vehicles: Rs. 1300/- per default or actual hire charges for other sources, whichever is higher; on misbehaviors complaint of user/mileage overwriting by the Driver: Rs.2000/- per default.
