

MATCHING EQUITY GRANT : Growth Engine to FPO Ecosystem

In India, Equity Grant Scheme holds prime importance in Agri ecosystem, as it extends vital support to the equity base of Farmer Producer Organizations (FPOs) by providing matching equity grants subject to maximum of Rs. 15.00 lakh per FPO in 3 tranches with in a period of 3 Years.

To commemorate Azadi Ka Amrit Mahotsav, the DA&FW, Gol has organized a two days' **National Conference of State Agriculture & Horticulture Ministers** in Bengaluru on 14-15th July, 2022 in the presence of Union Minister of Agriculture & Farmers Welfare **Shri Narendra Singh Tomar**, Chief Minister of Karnataka **Shri Basavaraj Somappa Bommai,** Ministers of State for Agriculture & Farmers Welfare **Sushri Shobha Karandlaje** and **Shri Kailash Choudhary** & Ministers of Agriculture & Horticulture of the States.

On the occasion, Gol released Equity Grant worth **INR 37.6 Cr to 1018 FPOs** across the country. Uncrewed Aerial Vehicles - KISAN DRONES

A real 'gamechanger' in Indian agriculture



Recently, the Government of India has released funds for various activities of Farm Mechanization under the Sub-Mission on Agricultural Mechanization (SMAM) scheme.

The Department of Agriculture & Farmers Welfare has brought out Standard Operating Procedures (SOPs) for use of Drone application with pesticides for crop protection in agricultural, forestry, non-cropped areas, etc. & for Drone Application in Spraying for Soil and Crop Nutrients.


- 22 registered drone manufactures and importers in India
- >40 Drone Training Institutes in India.
- Get the drone registered & generate UIN (Unique Identification Number)
- Eligibility : 10th Pass, >18Years & should be Certified Drone Pilot

The department of agriculture estimates that the service of a drone that has the capacity to carry a 10 kg payload will cost Rs 350-450 per acre. The subsidized purchase of agriculture drones for CHCs/

Hi-tech Hubs will make the technology more affordable, resulting in its widespread adoption. The amendments in the guideline make drones more accessible to the FPOs in India and will also significantly encourage use of Kisan Drone in the Indian Agriculture.

- Agriculture Training Institutes & KVKs -100% Funding Support up-to Rs. 10 Lakhs
- CHCs (by Cooperatives & FPOs) 40% support up-to Rs. 4 Lakhs

KEY TIMELINES: Post Incorporation Compliances for FPOs



Increase in Minimum Support Prices (MSP) -Kharif Crops



The Cabinet Committee on Economic Affairs, chaired by Hon'ble Prime Minister Shri Narendra Modi, recently approved an increase in minimum support prices (MSP) for 17 Kharif crops for the 2022-23 marketing season. Out of 17, 14 Crops revised MSPs has been published. The increase in MSP for Kharif crops for the 2022-23 marketing season was in line with the Union Budget 2018-19 announcement of fixing the MSP at a level of at least 50 percent over the all-India weighted average cost of production, aiming at a reasonably fair remuneration for the farmers.

FPO-Hulsoor Mahila Kisan Millets Producer Company limited IMPLEMENTING AGENCY: SFAC CBBO-ICAR-Indian Institute of Millets Research Hyderabad BLOCK CHC, Input sales, output sales, Millets grains KEY AREA- Value addition and processing of millets

The FPO resulted in a long-term change in the lifestyle of the farmers of Hulsoor block of Karnataka. Farmers used to cultivate traditional varieties of various crops before becoming members of the FPO using conventional farming methods. The FPO introduced millet as a new crop to the crop portfolio of these farmers. FPO has recently set up its own input shop, where members can buy high-quality seeds, fertilizer, and other inputs at subsidized prices. The FPO also has a Custom hiring centre, where farm machinery is accessible to the farmers.

The average crop productivity enhanced by 30–50% as a result of demonstrated crop cultivation techniques and Good Agricultural Practices to the FPO farmers.

FPO-Ansarwada Agronic Farmer Producer Company Limited IMPLEMENTING AGENCY: SFAC CBBO-Grant Thornton Bharat LLP BLOCK – Nilanga, latur district, Maharashtra KEY AREA- Output sales of Soyabean & Gram

For many years, the farmers in the initiative have struggled to find remunerative markets and have been compelled to sell their crops at a loss, making it impossible to break the cycle of poverty. FPC was able to produce good grade soyabean and gram with the support of technical farm advisory from CBBO and access to premium inputs at reasonable prices. Further, it also secure market linkage opportunities with processors in the region. Farmers can also get help from FPC's Custom Hiring Centre to access the farm machinery services. The FPO is concentrating on developing their own brand and adding value to Soyabean and Gram. FPC had a turnover of INR 2.68 crore in FY 2021-22. The FPO was also able to align with a state government program and has applied for a 1200 MT warehouse.


Before becoming a member of FPO, farmers used to sell their turmeric produce to the aartiyas in Sangali (Maharashtra), where they had to face several challenges like hefty charges in lieu of commission/brokerage, transportation, loading unloading charges, bags, quantity weight reduction per quintal (upto 3kh per Qtl) etc., cheating in weighting, no scope for bargaining late payment till 2-3 months after delivery etc., which subsequently causes less net profit to farmers. Since, Now Agri produce is aggregated and marketed through FPO, the farmers are getting fair price to their Agri produce and there is no possibility of cheating and late payment. In order to establish forward market linkages with Multinational Companies the necessary communication is being done.











Key addendum to Operational Guidelines

Under the guidance & chairmanship of MD SFAC Dr N. Vijaya Lakshmi, IAS; after receiving feedbacks from Implementing Agencies & NPMA; Central ministry has sought improvisation in Operational guidelines of the Central Sector Scheme on "Formation & Promotion of 10,000 FPO" & revised changes has been released as addendum on June 6, 2022. Amongst the multiple changes, Key addendum includes Relaxation in cap of 25 FPOs. Allotment of >25 FPOs to High performing CBBOs(up-to 50 across involved IAs). This needs to be carried out by every IA in a justified manner, as directed in approved SOP of Performance based allocation of FPOs. This SOP has been framed & broadcasted by NPMA to all the IAs on June 16, 2022

Release of CBBO Performance Assessment Tool

Performance of CBBOs will be assessed based on the CBBO Assessment Toolkit & shall be classified into high performing, average performing, and low performing CBBOs periodically by the IAs.

The acceptable performance threshold (70% or above) for CBBOs, as considered in the CBBO Assessment Toolkit, is revised and the CBBOs will be classified into three categories by adopting the class intervals as mentioned below:

Category of CBBOs Performance Score

- Low Performing Grade C- 0% to 40%
- Average Performing Grade B- 41% to 60%
- High Performing Grade A 61% to 100%





Post Harvest Management (PHM) SOPs released

Standard Operating Procedure (SOP) for effective Post Harvest Management (PHM) of "Fruits & Vegetables" & "Honey" has been released & published by SFAC.

The SOPs have been framed by keeping the right requirements of Farmers in mind. Effective PHM contributes to the following aspects - a) More availability & Utilization of Food; b) Stimulate consumption in local markets & an upward shift in demand; c) Increase market supply, eventually leading to lower farm-gate prices; & d) Higher income in Value chain.

Capacity Building of CBBO Domain Experts by BIRD

Bankers Institute of Rural Development (BIRD) has basic FPO module on their website as an open source material and also uploaded the MOOC (Massive Open Online Course). The MOCC course needs to be accessed after getting free registered. Hence CBBOs five domain expert (as per MoU signed with the respective IAs) needs to get registered on BIRD's website and complete the training as well as evaluation process for getting the completion certificate in next 45 days. This is a mandatory process for CBBOs to get their respective domain experts trained for the given modules related to Formation & Promotion of FPOs.
