#### **Introduction**

It's a great privilege to present before you, the  $1^{st}$  Annual Report of Krushidhan Producer Company Limited (KPCL).

On behalf of the managing board of the Krushidhan producer company, I take the honor to welcome you all to the  $3^{rd}$  annual general meeting of the company. Despite competition, we have been able to show better results in comparison to last year. The credit for this goes to all the members, shareholders, and staff and committee members of different regions who have been associated with DSC - Ahmedabad to make it possible.

Krushidhan Producer Company Limited (KPCL) is a company with is owned, managed and operated by the farmers of Gujarat. The main objective of the company is to provide support to small and marginalized farmers of the area. For this currently we aim at having five thousand shareholders and share capital of Rs twenty five lakhs. Company's head office is in Ahmedabad and regional offices are in Visnagar, Himmatnagar, Modasa, Meghraj& Dhari. The company in the year 2013-14, started agro centers for the benefit of it's shareholders and farmers of the region at Himmatnagar, Vadnagar, Modasa, Meghraj areas. A total of two thousand and thirty five male and female farmers are it's shareholders. Recently authorized share capital of Rs ten lakks seventeen thousand was created. Working capital of Rs thirty four lakhs thirty nine thousand was arranged from authorized share capital and sale proceedings. With this working capital, farm inputs like quality seeds, pesticides, insecticides organic inputs, scientific farm implements are sold to the shareholders and the villagers. During the working of last three years i.e. 2013-14, 2014-15 and 2015-16 more than fourteen thousand farmers of the region was provided timely inputs, as per their requirement and quality. Sales of inputs worth more than two crores were undertaken during the period. According to a rough estimate the company by providing inputs, locally to the farmers have provided a savings worth Rs threecrores to it's beneficiaries at the prevailing market price, while earing minimal benefit.

Since last two years the company has been promoting organic fertilizers, insecticides and weedicides under it's own brand. Approximately fifteen hundred hectare of agriculture farm is under organic farming.

In order to ensure that the farmers of KPCL project are able to get quality seeds of wheat, jowar, groundnut etc. from their own area for increased production, the company has ensured the production and sale of these seeds. Farmers have reported an increase of sixty to seventy kg yield / Bigha (i.e. two hundred forty to two hundred eighty kg / hectare) by the use of locally produced seeds.

KPCL with the help of DSC had opened a retail outlet in Bopal area of Ahmedabad. In this outlet, all shareholders, farmers clubs & SHG groups can sell their farm produce such as grains, cereals, spices, after proper value addition (cleaning, grading & packaging) according to the market standards. This year two hundred and thirty seven consumers have directly availed the farm produces worth Rs five lakks from the farmers. The producers earned 5% more price for their produce.

In the last two years more and more women farmers are becoming the share-holders of the company which is a matter of joy and appreciation for the company. We hope in the coming years more and more women farmers become shareholders of the company.

We the farmers and share-holders of the company are highly grateful to Development Support Centre, Ahmedabad (DSC) and Royal Bank of Scotland Foundation (RBSF) for their technical and financial support in terms of trainings, exposures, product promotion, admin support etc. to ensure that company becomes self-sustainable.

Small Farmers Agri business Consortium Delhi approved the application of fifteen hundred sixty shareholders for providing a matching equity grant to be used as working capital. Rs seven lakks eighty thousand has been approved by them for which the company is highly obliged.

Till date KPCL is not sustainable for the implementation of it's day to day activity, which is a drawback. To minimize this company needs to cover more than three thousand members in more than one hundred and eighty eight villages with a business turnover of Rs eight crores. This will include -

- Trading in seeds and medicines for agricultural use.
- Seven hundred and seventy tons of seeds production of various grains and cereals.
- Three hundred and eight tons of cattle feed production and sale.
- Three hundred and twenty nine tons of sales through retail outlet marketing
- Three thousand eight hundred and six tons of produce to be traded.

With the support of all the shareholders in achieving these objectives will help the company in attaining it's sustainability.

To undertake the activities of the company round the year, we are thankful to the chairman, Development Support Centre - Ahmedabad, R B S Foundation - Mumbai, Charter accountant Sri AmalduttDhruv and Sri KrineshJaiswal, company secretary Sri I R Patel.

Along with this we are also thankful to companies and distributers of the farm inputs like, seeds, implements, fertilizers, agro medicines etc. We are also thankful to SBI and other banks, foods and drugs department, Gujarat seeds certification agency, businessmen, sales tax department, Income tax department, farm produce marketing co-operative and others for their extensive support.

#### Brief Introduction about KPCL.

Krushidhan Producer Company Limited (KPCL), is company formed by the farmers of Gujarat for their own betterment. It was started in the year 2013 with one thousand seventy five share-holders and an authorized share capital of Rs. Five lakhs thirty seven thousand, extendable up to five thousand shareholders with an authorized share capital of Rs. Twenty five lakhs. The company operates from it's head office in Ahmedabad and Outlets at Visnagar, Modasa, Himmatnagar, Meghraj and Dhari.

Currently the company has it's outreach to fourteen thousand farmers in one hundred and seventy villages from eleven blocks in in five districts of Gujarat. Development Support Centre- Ahmedabad and R BS Foundation - Mumbaihave been providing technical and financial support towards the sustainability of company.

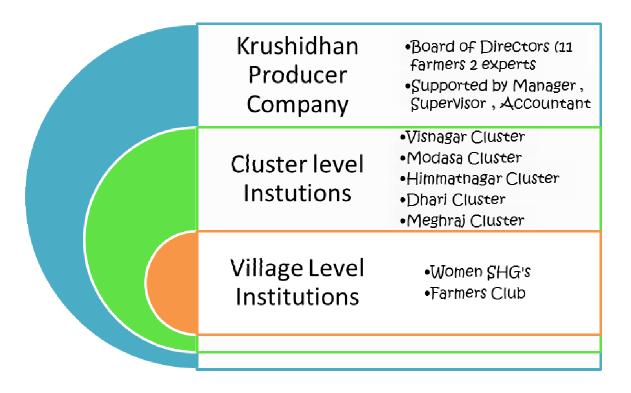


Figure 1: Field Implementation Area

#### Broad Objectives

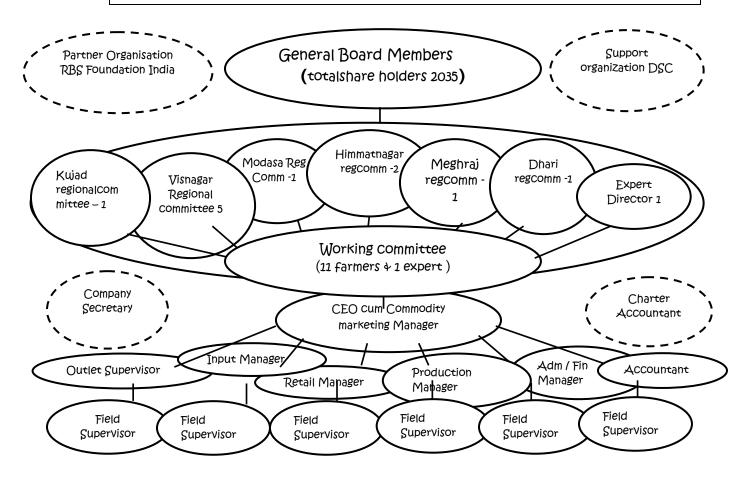
- Support farmer's specially small and marginalized towards their socioeconomic selfreliance.

#### ACTIVITIES UNDERTAKEN BY THE COMPANY.

- 1. The company was able to provide the basic farm requirement of the local farmers (i.e. seeds, agri-medicines, agri- equipment's, organic inputs etc.) to approximately sixty seven hundred farmers from one hundred and seventy villages through its retail outlets in different area. Farmers have purchased inputs worth more than Rs two crores on time as per their need and requirement. According to an estimate the local purchase of inputs instead of earlier market, have saved the farmers of the area more than Rs three crores, which was an additional benefit for the farmers.
- 2. Value addition to the farm produce undertaken by the shareholders from the field areas of KPCL, members of the Farmers clubs, women groups in the form of grading, packaging of farm produce, powdered spices, pulses etc. for retail marketing was also undertaken. Approximately thirteen thousand kgs of wheat, twelve hundred kg of pulses, nine hundred kg of spices were sold. The farmers have received 5% more price for their produce than the market price.
- Sixty seven tons of Wermi compost, two thousand four hundred and fifty Its of organic pesticides produced by the members of various groups were marketed through KPCL. Organic farming is being practiced in approximately fifteen hundred hectares.
- 4. Twenty five days mass awareness campaign was undertaken in which one hundred and ninety villages were covered with mobile display vans and print, audio-visual medias were used.
- 5. Farming related options, technology, metrological information's and suggestions were also provided through used of technology like voice and text messages and whatts-app to more than fifteen hundred shareholders to a tune of Rs One lakh seventy thousand.
- 6. During the years more than seven hundred shareholders, one hundred and fifty members of the cluster committee and twelve members of the board have been given specific trainings on seeds, best practices of various crops, value addition, shorting, packaging, marketing under expert guidance of Agriculture Universities, local traders, and agencies.

- 7. Bi-monthly meetings are undertaken at the cluster level committees at Visnagar, Vadnagar, Dharoi, Himmatnagar, Modasa, Meghraj, to ensure proper implementation of the prepared work plans and clearing out the bottlenecks.
- 8. During a year, Quarterly board meetings are undertaken to decide the policy issues, finalize the area wiseaction plan, review of physical and financial status, and future strategies of the company is decided.
- 9. Production of wheat seeds no 496 was undertaken by the farmers in Modasa and Himmatnagar clusters. A total of nineteen tons of seeds was produced and marketed by KPCL. The shareholder's / farmers who purchased these seeds experienced an increase in production of 60 to 70 kg / bigha. (240-280 kg / Hectare)
- 10. With the help of DSC, retail outlet of farm produce is being opened at Ahmedabad for direct sale to the consumers since last two years. More than two hundred thirty seven(237) consumers purchased products worth Rsfive lakhs from the retail counter.
- 11. More than six mobile cereals / spices, cleaning & grading machines have been provided at the cluster level committee. More than 300 farmers availed it's services and experiences and increase of 11 to 20 % in there selling price at the market.
- 12. KPCL has applied for matching equity grant of Rs 7.80 lakks for 1560 shareholders to the Small farmers Agribusiness Consortium, New Delhi. Accordingly they have visited, checked, verified and approved Rs 7.80 lakks.

#### Organizations supporting KPCL

Since 2012-13, Development Support Centre Ahmedabad and RBS Foundation Mumbai, have been supporting KPCL to achieve sustainability through its capacity building, providing necessary exposure and training and financial support for running it's office and operations on a day to day basis.

#### Problems faced

- Getting loans from banks is the biggest problem if the balance sheet of the company reflects small turnover and does not reflects any property.
- Variation in the local weather conditions due to the climate change phenomenon hinders the business plan of the company.
- Spurt in competition with the local farm input providers.
- Sales of products as per the rates decided by the local distributors of the company.
- Lack of company guidelines regarding purchase of farm produce from the farmers on the minimum support price as fixed by the central / state government, as it is dependent on their policy.
- Bad habits of the members / nonmembers on purchase of pesticides on credit only affect the business.
- Agreement was done for mass sale and purchase of farm produce with various reliable companies, but could not be implemented due to issues in production and local market conditions.
- Producer Company operates on low margins to benefit the farmers. Under such
  circumstances the cost of handling is more, hence along with business support from the
  members are required for management of the same.
