At the outset, Managing Director, SFAC, welcomed all participants and briefed them regarding RFP for appointment of SMP for Operation and Management of Delhi Kisan Mandi which is uploaded by SFAC at CPP Portal on 9th Oct,2018. MD clarified that with an object to link the fresh produce (fruits and vegetables) of FPOs to buyers and provide higher prices for their fresh produce.

SFAC is operating this mandi through SMP which provides post-harvest training, quality management and ensure direct linkage of FPOs with buyers. Through Delhi Kisan Mandi, SFAC encourages FPOs/GAs across the country to set up sorting, grading and packing facilities near the farm gate so that only sorted, graded and packed or semi-packed produces are made available for sale through Delhi KisanMandi. This platforms ensure better price and provide direct linkages which cut out intermediary.

The fundamental purpose is to benefit farmers for better price of their produce, better quality, no commission agent, no market fee/Cess and providing post harvest and marketing related training. This platform inculcate marketing skill into the seller so that over a period of time they will be able to market their produce by their own. MD, SFAC communicated that currently the platform is live, the new agency who ever will be selected should maintain the platform and run it in better way/approach.

On direction of MD,SFAC a brief presentation on RFP was done by TL(FPO). TL(FPO) explained the ToR, eligibility criteria and other details of the RFP. Bidder should provide a exclusive team for the said assignment. TL(FPO) explained that the produce of particular FPO can also be tied up with buyers available locally. Awareness campaigning needs to be undertake by selected agency and also exhaustive training programme on the related subject need to be undertaken by the agency.
