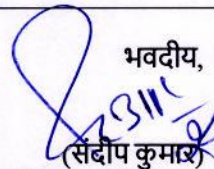

Please refer to your email dated 23.07.2025 on the above subject. In this regard, point wise reply is furnished as below:

Sl. No.	Question	Reply
a)	The details of farmer producer organizations (FPOs) presently functioning across the country's state-wise and district-wise in Andhra Pradesh and in Bapatla Lok Sabha Constituency;	Under the 10,000 FPOs scheme, all 10,000 FPOs have been registered in the country. The state wise FPOs registered under 10,000 FPOs scheme is attached as Annexure-I . District wise FPOs registered in the state of Andhra Pradesh under the scheme is attached as Annexure-II . In Bapatla District of Andhra Pradesh 28 FPOs have been formed under the Scheme.
b)	Whether the Government has taken any steps to promote Farmer Producer Organization across the country, if so, the details thereof;	Government of India has launched a Central Sector Scheme for "Formation and Promotion of 10,000 Farmer Producer Organizations (FPOs)" in 2020 in the country to facilitate and support the small and marginal farmers with the aim to form FPOs in every block of the country. One of the objectives of the scheme is to build capacity building of FPOs to develop agriculture entrepreneurship skills to become economically viable and self-sustaining with the support from Government of India.
c)	Whether the Government has undertaken any schemes/ initiatives for the development of FPOs over the last five years.	Till date all 10,000 FPOs have been formed with the beneficiary farmers of 36.90 Lakhs. As per the guideline of the "Formation and Promotion of 10,000 Farmer Producer Organizations (FPOs)" scheme, FPO provide special focus to include small, marginal and women farmers/women SHGs, SC/ST farmers and other economically weaker categories etc. as members to make FPOS more effective and inclusive. There shall be adequate representation of women farmer member(s) and there should be minimum one-woman member In the Board of Directors (BoDs). The FPOs get access to funds in form of FPO management cost, equity grant and credit guarantee facility apart from capacity building trainings, market and credit linkages etc. as below: • Provision of FPO Management Cost of Rs. 18 lakh/FPO for office and operational expenses. • Provision of matching Equity Grant upto Rs. 2000/- per farmer with the ceiling of Rs. 15 lakh/FPO.

		• Provision of Credit Guarantee up to project loan of Rs.2.00 Crore per FPO. • Capacity building, training and skill development of CEOs BoDs and other stakeholders
d)	If so, the details regarding the list of such schemes/initiatives, total amount of funding allocated, released and utilized over the last years, State-wise and district-wise in Andhra Pradesh and especially in Lok Sabha constituency; and	Central government has implemented several initiatives to incentivize and promote Farmer Producer Organizations (FPOs), focusing on financial support, infrastructure development and market access. • FPOs can avail assistance for setting up of Custom Hiring Centre (CHC) under Sub Mission on Agricultural Mechanization (SMAM). • Agriculture Infrastructure Fund (AIF): FPOs can access credit guarantee loans up to Rs. 2.0 Cr with an interest subvention of 3% per annum • Agricultural Marketing Infrastructure (AMI) sub-scheme of ISAM: FPOs can avail maximum Rs 50 lakh for storage & Rs 30 Lakh for non-storage infrastructure • PM Formalisation of Micro Food Processing Enterprises Scheme (PM FME Scheme): Credit linked grant @35% for micro food processing enterprises subject to a maximum of Rs.10 lakh. • Kisan Drones: Existing and new Custom Hiring Centers (CHCs), Farmers Producer Organizations (FPOs), and Rural entrepreneurs can receive financial assistance of 40% of the basic cost of the drone or Rs. 4 lakhs, whichever is less. • The efforts are made to provide the exposure to FPOs to different marketing platforms like ONDC and GEM to access the wider geographies and fetch better prices through different platforms. • FPOs can get assistance under oilseed mission and honey mission of Government of India. The State-wise payments to FPO is attached as Annexure-III. The District wise payments to FPOs in the State of Andhra Pradesh is attached as Annexure - IV
e)	Whether the Government has introduced any procedure to fast-track grievance redressal mechanism for FPO's across India, if so details thereof and if not reasons therefore?	Yes, the online grievance redressal mechanism under MIS portal is functional for FPOs across India under Central Sector Scheme for formation and promotion of 10,000 Farmer Producer Organizations. The CEO, Accountant and BoDs of FPOs may raise their grievances through the MIS portal to the respective Implementing Agencies. The link of the MIS portal is https://10kfpomis.dac.gov.in
