a)	Whether the all districts of Maharashtra have beneficiaries under key schemes such as Pradhan Mantri Kishan Maandhan Yojana, Paramparagat Krishi Vikas Yojana (PKVY) and schemes for promotion of Farmer Producer Organisations (FPOs) in Maharashtra;	<u>Farmer Producer Organisations (FPOs)</u> Under 10,000 FPO Scheme, 589 FPOs have been formed covering 34 districts of Maharashtra. The district wise list of FPOs formed in Maharashtra is attached as Annexure-I .
b)	Whether any there any district or area is left where benefits of such farmer welfare schemes have not yet reached;	Total 589 FPOs have been formed under central Sector Scheme of 10,000 FPO Scheme of Government of India in Maharashtra. Total 3,39,280 farmers are beneficiaries under these FPOs which includes 133449 (39%) women Farmers and 271540 (80%) are small and marginal Farmers in Maharashtra. New farmers are also joining the FPOS to get the benefits of the scheme especially aggregation of member produce to get better market and price.
