Till 31st October 2024, 1389 Mandis across the nation are onboarded on e-NAM portal. A total of 10.45 crore MT of various agricultural commodities and 40.64 crore Nos. of commodities like Coconut, Betel leaf, Sweet Corn, Lemon and Bamboo (which are traded in numbers) were traded. Total trade value of Rs. 3,79,330.13 crores have been recorded on e-NAM portal.
		2. Formation and Promotion of 10,000 FPOs: Government has launched a Central Sector Scheme for "Formation and Promotion of 10,000 Farmer Producer Organizations (FPOs)" on 29.02.2020 with a clear strategy to form and promote 10,000 new FPOs in the country to facilitate and support the small, marginal and landless farmers. FPOs formed under the central sector scheme get access to funds in form of FPO management cost, equity grant and credit guarantee facility along with capacity building trainings, market and credit linkages etc. As on date 9204 FPOs have been formed covering 34 states and 7178 blocks of the country (Annexure – I).
