

d)	the details of the Government's target for the number of mandis to be integrated into the e- NAM platform in the upcoming year and the manner in which Maharashtra and particularly Jalgaon district contribute to achieving this goal:	<p>Government has given the target of 150 mandis to be integrated on e-NAM platform during FY 2024-25 and FY 2025-26.</p> <p>As per the revised Operational Guidelines pertaining to 'Approval of Proposals and release of Assistance' (Section 7) states that "The Director of Agricultural Marketing of the State Government or the Managing Director of State/UT Agriculture Marketing Board, as the case may be, will submit the proposal through principal Secretary/ Secretary, In-charge of Agricultural Marketing, to the State Level Sanctioning Committee (SLSC) chaired by Chief Secretary. The SLSC will scrutinize and consider the proposal(s) for sanction of the same received on prescribed Pro-forma."</p> <p>If new proposals of the State Govt. of Maharashtra are received for integration of mandis on e-NAM, they shall be considered as per the guidelines.</p>
e)	the details of the impact of e-NAM on farmers' income, market access, and transparency in trade transactions in Maharashtra?	<p>As on 31.10.2024, 17.84 million farmers and more than 4250 FPOs are registered on e-NAM. e-NAM enables farmers to directly sell their produce to buyers, by passing intermediaries, which ensures better pricing and increased transparency. The platform provides access to broader markets, real-time pricing information, and e-payment systems, allowing farmers to receive timely payments. By offering quality grading, competitive bidding, and market intelligence, e-NAM empowers farmers to make informed decisions and maximize their profits.</p>
