

a)	The information on the implementation of the e-National Agriculture Market (e-NAM) platform across various States and Mandis	e-NAM was launched in 2016 to create a unified national market for agricultural commodities. 17.8 million farmers and 4250 FPOs in 1389 APMCs across 23 States and 4 UTs are registered on e-NAM. The information on the status of e-NAM across various States and Mandis till 31.10.2024 is enclosed as Annexure I .
b)	The number of mandis that have been successfully integrated into the e-NAM platform till date	Till 31.10.2024, 1389 mandis have been integrated on e-NAM. The State wise list of mandis that have been successfully integrated into the e-NAM platform till 31.10.2024 is furnished in Annexure I .
c)	The targeted number of mandis to be integrated for the upcoming year?	Target is to integrate 150 mandis on e-NAM platform during FY 2025-26.
